

# **Driving Directions**

#### From the San Francisco Bay Area - Approximately 2.5 hours

(Scenic) Take I-80 East just past Vacaville; take exit 56 for I-505 North for 21 miles; take exit 21 for Highway 16 West approximately 35 miles through the scenic Capay Valley and Cache Creek Canyon until you reach Highway 20. Turn left on Highway 20 and drive 500 feet before turning right onto Bear Valley Road. Follow this unpaved road for about 3 miles, then turn left on Wilbur Springs Rd and cross the Silver Bridge. Continue another half mile and you'll arrive at the Wilbur Hot Springs gate. Please open and close the gate behind you to keep cows out! Drive slowly to the hotel and park in Temporary Lot for Check-In.

(Interstate) Take I-80 East just past Vacaville; take exit 56 for I-505 North for 34 miles, then continue onto I-5 to North for another 18 miles to Williams; Take exit 578 for Highway 20 West, driving 18 miles until you reach the junction with Highway 16. Just 500 feet past this junction, turn right on Bear Valley Road. Follow this unpaved road for about 3 miles, then turn left on Wilbur Springs Rd and cross the Silver Bridge. Continue another half mile and you'll arrive at the Wilbur Hot Springs gate. Please open and close the gate behind you to keep cows out! Drive slowly to the hotel and park in Temporary Lot for Check-In.

# From Sacramento and Sacramento International Airport - Approximately 1.5 hours

(Interstate) Take I-5 North towards Redding for approximately 49 miles to Williams; Take exit 578 for Highway 20 West, driving 18 miles until you reach the junction with Highway 16. Just 500 feet past this junction, turn right on Bear Valley Road. Follow this unpaved road for about 3 miles, then turn left on Wilbur Springs Rd and cross the Silver Bridge. Continue another half mile and you'll arrive at the Wilbur Hot Springs gate. Please open and close the gate behind you to keep cows out! Drive slowly to the hotel and park in Temporary Lot for Check-In.

**(Scenic)** Take I-5 North for approximately 13 miles to Woodland; take exit 541 for Highway 16 West towards Esparto. Continue following signs for 16 West through Esparto and stay on Highway 16 approximately 35 more miles through the scenic Capay Valley until you reach Highway 20. Turn left on Highway 20 and drive 500 feet before

turning right onto Bear Valley Road. Follow this unpaved road for about 3 miles, then turn left on Wilbur Springs Rd and cross the Silver Bridge. Continue another half mile and you'll arrive at the Wilbur Hot Springs gate. Please open and close the gate behind you to keep cows out! Drive slowly to the hotel and park in Temporary Lot for Check-In.

#### From Petaluma / Santa Rosa - Approximately 2 hours

Take Highway 101 North to exit 494 for River Road / Mark West Springs Road; Turn right onto Mark West Springs Road for approximately 10 miles. At stop sign, turn left onto Petrified Forest Road for approximately 4.5 miles; at stop sign, turn left onto Hwy 29 / Foothill Blvd for approximately 1 mile, then turn right on Tubbs Lane; at the end of Tubbs Lane, turn left onto Hwy 29 / Lake County Hwy. Follow Hwy 29 about 20 miles, over Mt. St. Helena (very curvy) and through the town of Middletown to Lower Lake; stay straight, continuing onto Hwy 53 North for approximately 8 more miles to reach the junction of Highway 20. At the roundabout, take Hwy 20 East for approximately 18 miles. About 3 miles after entering Colusa County, turn left onto Bear Valley Road (if you reach Hwy 16 you've gone too far). Follow Bear Valley Road (unpaved) for about 3 miles, then turn left on Wilbur Springs Rd and cross the Silver Bridge. Continue another half mile and you'll arrive at the Wilbur Hot Springs gate. Please open and close the gate behind you to keep cows out! Drive slowly to the hotel and park in Temporary Lot for Check-In.

## From Napa Valley - Approximately 1.5 hours

Take Highway 29 North through Calistoga. Turn right on Tubbs Lane; at the end of Tubbs Lane, turn left onto Hwy 29 / Lake County Hwy. Follow Hwy 29 about 20 miles, over Mt. St. Helena (very curvy) and through the town of Middletown to Lower Lake; stay straight, continuing onto Hwy 53 North for approximately 8 more miles to reach the junction of Highway 20. At the roundabout, take Hwy 20 East for approximately 18 miles. About 3 miles after entering Colusa County, turn left onto Bear Valley Road (if you reach Hwy 16 you've gone too far). Follow Bear Valley Road (unpaved) for about 3 miles, then turn left on Wilbur Springs Rd and cross the Silver Bridge. Continue another half mile and you'll arrive at the Wilbur Hot Springs gate. Please open and close the gate behind you to keep cows out! Drive slowly to the hotel and park in Temporary Lot for Check-In.

## From Ukiah / Mendocino County - Approximately 1.75 hours

Take Highway 101 to Highway 20 (near Redwood Valley). Take Highway 20 East for approximately 42 miles, past the town of Clearlake Oaks. (There are several roundabouts

along this route, which follows the northern edge of Clear Lake -keep following signs for Hwy 20 East). After Clearlake Oaks, go through one last roundabout, continue on Highway 20 for 18 more miles. About 3 miles after entering Colusa County, turn left onto Bear Valley Road (if you reach Hwy 16 you've gone too far). Follow Bear Valley Road (unpaved) for about 3 miles, then turn left on Wilbur Springs Rd and cross the Silver Bridge. Continue another half mile and you'll arrive at the Wilbur Hot Springs gate. Please open and close the gate behind you to keep cows out! Drive slowly to the hotel and park in Temporary Lot for Check-In.
